Statement Overview

Endeavour Foundation Limited (ABN 80 009 670 704) is a reporting entity under the Modern Slavery Act 2018 (Cth). This statement covers the activities of Endeavour Foundation and its controlled entities for the period 1 July 2023 to 30 June 2024. It outlines the steps Endeavour Foundation Limited and its controlled entities have taken to identify and address modern slavery risks in our operations and supply chains.

Governance Framework

Endeavour Foundation is a member-based organisation governed by a Board of Directors, both appointed and elected. They provide a balance of corporate expertise and lived experience of disability. Additional oversight is provided by the following Board Committees:

- Audit, Finance, Risk and Compliance Committee
- People and Culture Committee
- Client Care Committee.

Our controlled entities are governed by their own Boards.

Endeavour Foundation's governance arrangements are set out in our Constitution and By-Laws. All officers, executives, employees and volunteers are required to abide by our Code of Conduct.

Operations

Endeavour Foundation operates primarily in Queensland, New South Wales and Victoria, with smaller operations in other states and territories supporting individuals employed under the Defence Assistance Program.

Home and Community

An integral part of the Endeavour Foundation family, the Home and Community Division operates in Queensland, New South Wales and Victoria. Our Home Portfolio operates 24/7 services that support people with disability who want to live independently, by providing flexible options for living arrangements. Supported Independent Living is supported accommodation that provides greater independence while ensuring residents have the support needed to navigate daily life.

Through our Community portfolio we support people with disability to gain experiences and develop skills within a community environment through a variety of programs. Programs allow people with disability to be as independent as possible and live their best life.

Work

Our Work Division actively focuses on creating employment opportunities for people with disability. We collaborate with corporate partners and mainstream employers to provide a range of pathways and training programs, helping people achieve their personal employment goals.

Community Solutions and BRACE

Community Solutions and BRACE are dedicated to providing inclusive and diverse support services in Queensland, New South Wales and Victoria. This division empowers people, families and communities to realise their full potential through employment, education, training and specialised disability support services.

Supporting Functions

The above services are supported by our Finance, Infrastructure and Lotteries; Legal and Governance; People and Wellbeing; and Fundraising, Advocacy, Marketing and Engagement Divisions.

Modern **Slavery Risks**

We are committed to acting ethically in our operations and throughout the supply chain, this includes continually evolving how we integrate modern slavery risk reduction activities into standard procedures. How we mitigate the risk of modern slavery in our operations and supply chain is set out further in this Statement.

The term modern slavery encompasses a range of human rights violations including trafficking in persons, slavery; servitude, forced marriage; forced labour; debt bondage; deceptive recruiting for labour or services; and forms of child labour. In identifying modern slavery risks in our operations and supply chain, we acknowledge organisations may directly or indirectly cause or contribute to modern slavery.

Endeavour Foundation's risks of involvement in modern slavery are:

- as a purchaser of goods and services there is a risk we could purchase goods or services which involved modern slavery practices in their creation or provision
- as an employer there is a risk that labour could be exploited within our workforce.

Potential modern slavery risks in our operations

As an employer, we recognise there is a risk of modern slavery in our operations. We recognise risk indicators such as:

- low-skilled workers, with a substantial number from cultural and linguistically diverse and new migrant background
- utilisation of third-party labour hire relationships.

We assess there is currently minimal risk of causing, contributing or being directly linked to instances of modern slavery within our operations. Our workforce comprises employees, contractors and volunteers. Our directly employed staff are engaged by contract, award or collective industrial agreement.

We have processes in place to ensure our employees are treated fairly, including:

- confirming right to work in Australian via visa status checks
- ensuring all employment is covered by a regulated industrial agreement
- policies and procedures addressing fair and equitable treatment, diversity and human rights.

In the reporting period, we have also worked extensively to reduce the reliance on labour hire staff to fill vacancies in our rosters.

We also engage with a range of commercial clients in our business solutions (Work) sites to provide services related to packaging, recycling, timber products and document destruction. As a provider of various business solutions there is a risk that we are indirectly contribute to modern slavery through our commercial relationships with partners in the following higher-risk industries agriculture, timber product manufacturing and recycling. During this reported period, we engaged with a number of commercial customers for the first time on their modern slavery risk identification and risk mitigation activities. In addition, a number of our customers undertook due diligence on Endeavour Foundation's operations including a SMETA¹ SEDEX audit.

Potential modern slavery risks in our supply chain

We recognise that through our supply chain, there is a risk we may contribute to or be indirectly linked to modern slavery. In recognition of this potential as a purchaser of goods and services, we have:

- considered the Commonwealth Government guidance on modern slavery risk indicators - geographic, products, services, sector and industry, and entity²
- · researched high risk areas for our sector and operations
- have undertaken an assessment of our suppliers and commercial partners to identify potential risks associated with high-risk industries, products and source countries.

ICT hardware

ICT hardware is recognised globally as a highrisk category due to the prevalence of modern slavery practices in the manufacturing process. There is a risk that Endeavour Foundation may indirectly contribute to modern slavery practices through the purchase of electronic devices and computer hardware.

Building and construction

The building and construction industry is recognised to involve long supply chains and use base-skilled workers which are risk factors for modern slavery. As a result, there is a risk that Endeavour Foundation may indirectly contribute to modern slavery through construction of residential properties and lottery prize homes, as well as furnishing of the same.

Outsourced services

Outsourced services have been identified as a high risk for modern slavery. Our cleaning and building maintenance services are outsourced. There is a risk that Endeavour Foundation may indirectly contribute to modern slavery practices through our arrangements for facilities management.

Actions Taken

We continue to assess our supply chains and operations for potential risks of direct or indirect involvement in modern slavery. This reporting period we built on earlier work by:

- completing a risk assessment of over 150 of our suppliers and commercial customers based on spend, sector, source country of products, whether they have published a Modern Slavery Statement and contractual arrangements
- asking suppliers and commercial customers who have been rated a high or medium risk, within our risk management framework, to complete a modern slavery due diligence questionnaire
- the Procurement and Policy & Governance Teams undertaking modern slavery training
- cooperating with commercial customers to ensure they met their modern slavery obligations

- undertaking self-assessment against the National Child Safe Principles and developing and implementing policies, procedures and systems to meet the requirements of being a child safe organisation
- successfully completing a SEDEX (Supplier Ethical Data Exchange) full audit at our Bundaberg site with favourable results
- SEDEX vetting our Annual Supplier Assessment Questionnaire conducted over six sites
- reviewing and updating our Modern Slavery Policy.

Through these actions, there have not been identified any indicators or incidents of concern.

Key Actions Delivered

We refined our supplier risk assessment

We continued to build awareness of modern slavery risks by providing training for key staff.

We identified over 150 suppliers as having a higher risk.

We focussed on higher-risk suppliers, including identifying where engagement and further action is required.

We continued to strengthen our procurement process.

We updated contract templates.

We sought additional information from key suppliers on their risk mitigation activities.

Worked with commercial partners to assist in mitigating risks in supply chains.

Effectiveness of Actions Taken

As noted above, during the reporting period, our focus was on continuing to develop our understanding of our modern slavery risks and how such risks present in our operations and supply chains.

We assessed our effectiveness by tracking the progress of our initiatives and engaging with suppliers. Our modern slavery risk management action plan and risk mitigations are reviewed regularly. We also recognise the challenge in assessing the effectiveness of our initiatives due to the complexity of modern slavery and that many of the risks may exist deep in our supply chains, where our visibility and ability to influence suppliers is more difficult.

Looking Forward

Endeavour Foundation has adopted a continuous improvement approach to our obligations under the Modern Slavery Act 2018. Our ongoing focus is to cement our due diligence activities as usual practice in engaging with suppliers and commercial customers.

In the next reporting period we aim to:

- identify the most appropriate training modules to provide to employees
- continue to strengthen our practices by implementing a risk-based due diligence toolbox to enable assessment of modern slavery risk prior to onboarding, contract award or contract renewal
- improve our data systems to enable more effective spend analysis
- continue refinement of our due diligence and response activities for managing modern slavery risk.

Consultation with controlled entities

Endeavour Foundation is a reporting entity under the Modern Slavery Act 2018. This statement covers activities of Endeavour Foundation and its controlled entities. In preparing this statement, Endeavour Foundation consulted its controlled entities. The directors and officers of all entities were consulted and provided with an opportunity to review the statement prior to is approval by the Board of Endeavour Foundation.

Board Approval

This statement for Endeavour Foundation and its controlled entities was approved by the Board of Endeavour Foundation Limited as the parent entity on 28 November 2024.
