Workplace giving is a simple, tax effective way to give people with disability the opportunity to realise their dreams.

By pledging a nominated amount to be deducted from your pre-tax pay, you're helping people with disability live life to the full and make the most of every opportunity.

How are funds used?

Your regular donations provide the services and supports that help our most vulnerable Australians live their best life.

Did you know that NDIS funding and government grants only account for 68% of what is needed to ensure people with disability can live their best lives? What gets us to 100% of what is needed is people like you.

Your donations contribute towards things that make possibilities a reality – such as virtual reality kits, iPads to provide vital learning, suitable housing for people with disability to call home, and literacy aids such as notebooks and pens.



How does it work?



The tax benefit is received immediately without having to wait until the end of the tax year or collect receipts.

You can change or cancel your donation at any time by contacting your Payroll team.

Workplace giving does not affect your superannuation or payroll tax calculations and is not counted as a fringe benefit. A workplace giving donation reduces your PAYG liability without decreasing your gross income.

If your organisation has chosen to match donations, your contribution means that Endeavour Foundation will receive double the amount of your pledge towards supporting people with disability.
